Working with AGA-Africa allows for us to recognize and examine what we are doing in the United States to combat transnational crimes, what is working, what is not, and what we can actively do to help those in other continents and countries fight against these issues as well. Core Mandate Areas

In 2021, AGA-Africa addressed its core mandate areas as outlined below, each providing a synopsis of how specific areas have been addressed in different countries.

Anti-Human Trafficking

An increasing number of countries in Africa and indeed the world over can be classified either as source, transit, or destination countries for victims of human trafficking. Human trafficking falls into a number of categories and these may include: forced labour, sexual exploitation, and organ trafficking. It is generally acknowledged that in many cases, it is increasingly difficult to identify, investigate and prosecute human trafficking cases.

AGA-Africa training programmes and seminars on human trafficking are focused on how to identify, investigate, and prosecute human traffickers as well as share best practice in the protection and rehabilitation of actual or potential victims of trafficking. As a partner in justice, AGA-Africa also organizes seminars and conferences as forums which enhance awareness, knowledge and the skills required to combat human trafficking.



Core Mandate Areas and how they were tackled in 2021 $\,$

Fighting Cybercrime

According to the African Cyberthreat Assessment Report 2021 published by INTERPOL, cybercrime is a global threat, but weak networks and weak security have made Africa especially prone to cyber threats. The report also lists online scams, digital extortion, business email compromise, ransomware and botnets as the top 5 cyberthreats in Africa.

AGA-Africa works with stakeholders engaged in tackling cybercrime to build and strengthen internal capacity. AGA-Africa strives to promote awareness on the dangers of cybercrime in addition to facilitating workshops focused on the investigation and prosecution of cybercrime. In 2021, AGA-Africa organized vibrant engagements on this emerging subject matter.

Combating Counterfeit Drugs

The sale of counterfeit drugs is a huge global challenge, with devastating effects. According to the World Health Organization (WHO) about 800,000 deaths a year in Africa are linked to the counterfeit drug trade. Counterfeit products may include:

- Products with the correct ingredients or
- With the wrong ingredients,
- Without active ingredients,
- With incorrect quantities of active ingredients or – with fake packaging.

In 2021, AGA-Africa organized the following event towards curbing this menace:

Anti-Money Laundering and Financial Crimes

Money laundering is frequently linked with other transnational crimes such as terrorism, human trafficking, wildlife trafficking and other global crimes. According to the Financial Action Task Force (FATF), money laundering by its

very nature is an illegal activity carried out by criminals, which occurs outside of the normal range of economic and financial statistics. The report estimates that in 2009, criminal proceeds amounted to

3.6% of global GDP, with 2.7% (or USD 1.6 trillion) being laundered. In 2021, AGA-Africa responded to the need expressed for training on this subject. The following events took place:

figures for the value of illegal wildlife trade.

AGA-Africa works in concert with anti-wildlife trafficking actors to create greater awareness about the detrimental impact of wildlife crimes and to provide training for investigation and prosecution of wildlife traffickers. In its efforts

Gender-Based Violence



Prosecution of Electoral Offences

AGA-Africa held the first Prosecution of Election Offences training in partnership with the National Prosecuting Authority of Zambia. The training also ensured that prosecutors are kept abreast with the current trends in the prosecution of electoral offences in light of the amended and new legislation.

Refugee Law

In its efforts to meet stakeholders requests, AGA-Africa partnered with the then Judiciary Training Institute (now Kenya Judiciary Academy) for a Refugee Law workshop. The motivation behind the unique training was that Kenya is signatory to a number of international treaties applicable to individuals seeking asylum and protection. These international obligations were consolidated through the enactment of the Refugees Act in 2006 which took effect the next year. Since the enactment of the Act, it is in 2021 that the first appeal from the Refugee Appeal Board to the High Court was filed The appeal is pending for hearing and determination hence the need for urgent capacity building in this subject. The objective of the training was to equip Judges with knowledge on and enhance their skills in applying the principles, law, and policies relating to the protection of refugees.

The event was brought to close by **Hon. Betty Mould-Idrissu** and **Maame Hagan,** AGA-Africa Country Coordinator for Ghana.



AGA-Africa in collaboration with the Criminal Investigation Department and Cybercrime Unit, Ghana Police Service held a four-day workshop titled "Cybercrime and Electronic Evidence".

The workshop objective was to train cybercrime investigators and prosecutors within law enforcement agencies on the Cybersecurity Law (Act 1038) of Ghana. This enhanced the capacity, knowledge and skills of law enforcement officers to mount effective investigation and gather credible evidence for successful prosecution of cybercrimes.

The keynote addresses were delivered by Markus Green Esq, AGA-Africa Board Member and Frederick Kwadwo Agyei, Deputy Director General Ghana Police on behalf of COP Isaac Ken Yeboah, Director General Criminal Investigation Department, Ghana Police Service.

Frederick Kwadwo Agyei observed that Ghana's economic and professional operations have become increasingly reliant on digital technology. "Unfortunately for us some criminal elements have taken advantage of the pervasiveness to perpetrate crime. Some of these crimes have become possible due to human errors, social engineering, unpatched software and use of malicious software, among others."

Alexander Oppong, Principal Consultant e-Crime Bureau, representing Acting Director General of Cyber Security Authority **Dr. Albert Antwi-Boasiako,** noted that all over the world, cybercrimes have become a growing problem demanding huge investments to develop the skills of police and other personnel. "Cybercrimes are national security threats. As they increase in number so too must the police increase in skills to deal with them," he said.



In keeping with its mandate to stem human trafficking, AGA-Africa in conjunction with the Judiciary Training Institute (JTI) and the Anti-Money Laundering and Trafficking of Human Beings Project (AML-THB) organized a 3-day training for Magistrates themed 'Human Trafficking' on 17th-19th February, 2021.

Drawing from best practice and prosecutorial experience in other established jurisdictions, the training involved candid discussions amongst the participants exploring all relevant applicable legislation recommending means of implementation as well as the importance of National, Regional and International cooperation.

The training was officially opened by Markus Green, AGA-Africa Board Member, with keynote addresses from Hon. Mr. Justice Kathurima M'Inoti, Director Judiciary Training Institute via video link and Frédéric Bayard, Project Director EUTF AML-THB in the GHoA Project who was present at the venue.

Joining the workshop virtually, Markus Green emphasized the extreme importance of the topic as it cuts across the very fabric of humanity. "The notion of exploiting

a human being and using them over and over for profit is the greatest humanitarian crisis of our lifetime," he said.

Speaking from Naivasha, Frédéric noted that whereas magistrates were typically at the end of the conversation, they do have an educational role by taking heavier sentences in such cases. He emphasized the need for an integrated approach with regards to training.

Hon. Justice Kathurima M'Inoti acknowledged the invaluable support of AGA-Africa and the Anti-Money Laundering and Trafficking of Human Beings (AML-THB). He noted that human trafficking was a serious crime, and notwithstanding the efforts to combat the crime Kenya has made, it is still ranked in Tier 2 out of a possible 4.

The training was attended by **Hon. Lady Justice Martha Koome**, Chief Justice and President of the Supreme Court of Kenya, **Hon. Justice Smokin C. Wanjala**, Judge of the Supreme Court of Kenya and Director of the Kenya Judiciary Academy and **Markus Green** Esq. AGA-Africa Board Member.

AGA-Africa was also honoured to have as facilitators: **Hon. Justice Anin Yeboah**, Chief Justice and the President of the Supreme Court of Ghana, **Hon. Mr. Justice Musa Dattijo Muhammad** Justice, Supreme Court of Nigeria and **Hon. Justice Healey Potani**, Justice, Supreme Court of Appeal, Malawi.

"The Supreme Court has the Jurisdiction for preserving the pristine authority of the constitution and the judiciary can guard its autonomy and independence through the constitution," said **Hon. Justice Kwasi Anin-Yeboah**, Chief Justice of Ghana.

In his remarks Hon. Justice Musa Dattijjo Muhammad, Supreme Court, Nigeria, asserted, "The Supreme Court provides a guide for all lower courts for interpretation and enforcement of rule of law. It ensures uniformity and discipline during dispensation of judgments."

Justice Healeu Hon. Potani. Supreme Court Malawi, observed that Kenya is the pioneer in resolving election disputes in Africa, following the landmark annulment of the 2017 Presidential elections. He added. "An election is not an event. It is a cycle including voter registration, campaigns, vote counting, results announcement. and Disputes can occur during any point of the cycle hence the need for proper jurisprudence from across the continent on how to handle these disputes."

AGA-Africa in partnership with the Kenya Judiciary Academy (KJA) and the Commonwealth Secretariat organized two sets of workshops themed "Cybercrime and Electronic Evidence Training for Magistrates" on 10th – 12th November and 17th – 19th November 2021, respectively.

The objective of the training was to equip magistrates with critical

tools and knowledge on handling cybercrime cases and electronic evidence and how to identify if the evidence presented in court is credible, compliant and respectful of human rights. This would enhance their capacity in adjudicating cybercrime cases.

The first training was attended by Hon. Justice Smokin C. Wanjala, Judge of the Supreme Court of Kenya and the Director of the Kenya Judiciary Academy, Markus Green, AGA-Africa Board Member (virtually), Jonathan Ratel, Legal Adviser (Criminal Justice Systems) Governance and Peace Directorate with AGA-Africa International Advisor, John Edozie and Chukukere Unamba-Oparah, Programme Director and Strategic Advisor present at the venue. The magistrates were also joined by 3 representatives from the Judiciary Training Institute Somalia.

In the first set of trainings, Markus Green spoke to the global nature of cybercrime as he reiterated that magistrates are on the front line hence needed the necessary tooling. He noted that in Kenya, Cybercrime accounts for losses worth billions. "The judiciary is a key piece of the criminal justice system," he said.

Jonathan Ratel, Legal Adviser (Criminal Justice Systems) Governance and Peace Directorate noted that Cybercrime is a top priority for not just the Commonwealth Secretariat, but a great many International Organizations. He noted that organizations spending more time on cyberspaces created opportunities for bad actors.

Hon. Justice Smokin C. Wanjala recognized AGA-Africa's continued partnership, which culminated with a renewal of their partnership via the renewal of their MoU during the Supreme Court Induction Training held in October 2021. "KJA looked forward to continued partnership," he said.

The second training was officially opened by Markus Green Esq, AGA-Africa Board Member, Hon. Justice Smokin Wanjala SCJ, Director Kenya Judiciary Academy and Supreme Court of Kenya Judge and Dr. Tawanda Hondora, Head of Rule of Law, Commonwealth Secretariat, Commonwealth Secretariat delivered keynote speeches during the opening.

In the second set of trainings, Hon. Justice Smokin C. Wanjala noted that Kenya has been referred to as a playing field for cybercriminals. He added that the ramifications have far reaching implications beyond the borders making the training crucial.

In his remarks, **Dr. Tawanda Hondora**, Head Rule of Law, Commonwealth Secretariat disclosed that in the next 4 years, the Commonwealth Secretariat would be working on cybercrime and seeking to raise awareness and engage in capacity building activities.

"The topic at hand has routinely been identified as an area that requires attention," **Markus Green**, AGA-Africa Board Member said. He added that magistrates are at the front line, the centre of the storm and this was an opportunity to add to their ever evolving tool boxes.

Dr. Steven Kayuni observed that Malawi is a destination of a complicated Trafficking in Persons (TIP) business but does not have enough resources to deal with the problem. "There is also more need for coordination of agencies to end this act," he said.

In his remarks, His Lordship Justice A. Chipeta, SC noted that in its effort to combat these offences, Malawi has had to scale up efforts to combat the scourge through workable strategies using the 4P Paradigm of Partnership, Prosecution, Prevention and Protection.

"One would have imagined human trafficking must have reduced with the pandemic. It has not," **Hon.**Justice Isaac Lenaola said in his remarks, adding that women and children are especially vulnerable.

Markus Green acknowledged that human trafficking is near and dear to the mission of AGA-Africa. "Individuals being held against their will is an incredibly disheartening practice," he said. "We are all connected. If we can rescue a girl in Malawi, we can impact another in Minnesota."

Asset Forfeiture done effectively there is need for partnership among various stakeholders including government, private sector and law enforcement." said Willie Hofmeyr, retired Deputy National Director of Public Prosecutions. JP Willemse, Senior Financial Investigator, noted that if you can follow the money in any given organization, you will be at the top or near the top of the organization. He added, "Because money is evidence, intelligence, liability and an investigative tool. We need to apply the same theory when it comes to Money Laundering."



The objective of the training was to achieve capacity building, educate, train and equip participants with knowledge from the thoughtprovoking discussions on the different types of Ponzi schemes that are expected to become prevalent in this era of increased use of cyberspace.

The training which was attended by Letitia James, Attorney General of New York was officially opened by Markus Green, AGA-Africa Board Member. with opening statements from Zainab Shamsuna, Minister of Finance, Budget and National Planning represented by Aliu the Permanent Secretary, Mohammed, Abubakar Malami, SAN, Hon. Attorney General of the Federation and Minister of Justice represented by Abiodun Aikomo (Special Adviser to the Attorney General), Lamido Yuguda, Director-General of SEC, Nigeria and Ibrahim Babaginda, Chairman, House of Representatives Capital Market.

In her remarks, **Letitia James** urged investors to be wary of promoters

who promise enormous gains to sell miraculous products.

In his speech read by Abiodun Aikomo, Attorney General Abubakar Malami commended the organizers for putting the training together. "There have been several Ponzi schemes since Charles Ponzi's scheme in the early 1920s," he said. "The Internet now helps Ponzi schemes more as they have a wider reach."

Zainab Shamsuna, represented by Aliu Mohammed, pointed out that Ponzi schemes have become a source of concern to policy makers. "The government of His Excellency, President Muhammadu Buhari (the President of Federal Republic of Nigeria) is bent on ensuring the protection of our economy as seen in the Finance Act which seeks to aid regulators to create a more robust economic system."

Lamido Yuguda affirmed that Securities and Exchange Commission (SEC) has a statutory duty to educate investors on the economy. He acknowledged that the webinar has that aim and aids the Commission's quest to educate the regulators and stakeholders. "Ponzi schemes undermine the regulatory efforts at growing the capital market and reduce the investors' interest in the capital market in Nigeria."

Ibrahim Babaginda observed that Ponzi schemes are similar to pyramid schemes and called it a 'special type of fraud' where the schemers are paid by the subsequent investors adding that they are on the rise.

In his remarks. Markus Green

acknowledged that the pandemic caused a lot of harm to businesses and with it made illegal businesses such as Ponzi schemes a huge market.

To help mitigate the financial consumer protection issues during the pandemic, AGA-Africa in collaboration with the Department of Mercantile Law, Faculty of Law, University of Pretoria (UP) held a one-day webinar themed Financial Consumer Protection on 22nd April 2021 in South Africa.

The webinar was designed to bring up critical discussions of the scams in the financial sector and financial consumer protection during Covid-19

pandemic. The discussions included a broader perspective of the illegal and/or unfair commercial practices as well as fraudulent and deceptive activity that negatively affect the financial wellbeing of consumers.

The webinar was attended by Aaron Ford, Attorney General, Nevada and officially opened by AGA-Africa Board Member, Markus Green, with Prof. Jacolien Barnard, Associate Professor, Department Mercantile of Law, Law Faculty, University of Pretoria and Mercy Buku, AML/CFT Legal and Risk Management Consultant, Banking and Digital Financial Services Sector from Kenya co-moderating the event.

Aaron Ford observed the rise in phishing scams, especially under the pretext of a warning message from the WHO in the Covid era. He cautioned that such scams can introduce malware and compromise a victim's personal information. He listed social engineering scams, online gaming scams, product scams as those that have risen during the pandemic.


Professor Jacolien Barnard pointed out that no one can tell when the pandemic might end hence the need for a conversation around Financial Consumer Protection that goes beyond investment scams.

In his remarks. Markus Green observed that consumers are financiallu and psychologically vulnerable and this situation broader than typical the financial scams necessitating the conversation.

Ouma Rabaji-Rasethaba,** Deputy National Director of Public Prosecutions, South Africa and officially opened by **Markus Green,** AGA-Africa Board Member, and **Kim Robinson,** AGA-Africa Country Coordinator for South Africa.

Attorney General **Thomas J. Donovan Jr.** proposed that the best way to enforce the law is to give people the opportunity to comply with it as he also expressed doubt that people actually know the rules of crypto currencies. "When consumers understand what the rules of the game are, they are likely to follow the law. Government

can create clear, predictable lines that people can follow. It is good for consumers, business and government integrity and makes it easier to find the bad guys," he said.

Pieter Smit, delivered apologies from Adv Xolisile Khanuile, Director, Intelligence Centre. Financial South Africa. He noted that crupto assets are a new development. He underscored that the purpose of the webinar is to understand a little more about how crupto assets work (and not resign to fate), with a focus of familiarizing with the basic concepts and tools available to law enforcement and how law enforcement can collaborate with industry players.





Freda Mwamba-Brazle observed that financial innovation's distinct features have also created new opportunities for money launderers, terrorist financiers and other criminals to launder their proceeds of financial illicit activities.



AGA-Africa collaborated with the National Prosecution Authority of Zambia, for an informative three-day training titled "Asset Recovery / Forfeiture" from 15th - 17th November, 2021.

The training was aimed at building the capacity of the investigators and prosecutors on how to effectively apply the Forfeiture of Proceeds of Crime Act No. 19 of 2010 of Zambia in the performance of their duties. This was done through equipping them with knowledge and skills on preparation of applications for restraining orders and confiscation orders that will assist them in the identification, investigation, seizure, prosecution and adjudication of asset recovery cases.

The workshop was officially opened by Markus Green Esq. AGA-Africa Board Member followed by brief welcome remarks from Fulata Lillian Shawa-Siyunyi (SC), Director of Public Prosecutions, Zambia with Jack Mwiimbu, Minister Home Affairs and Internal Security delivering the keynote speech on behalf of His Excellency Hakainde Hichilema, President of the Republic of Zambia.

In his speech read on his behalf by Jack Mwiimbu, Minister Home Affairs and Internal Security, H. E. President Hakainde Hichilema maintained that Asset Recovery is anchored on the principle that dirty hands must not profit. "This is rooted in the maxim that blood stained hands must not inherit and that there should be no unjustified enrichment at the expense of others."

"Criminals continually get seduced by the financial allure of criminal gains and continue to show impunity despite the deterrent measures put in place," said **Mulambo Hamakuni Haimbe**, Minister of Justice, Zambia said during the opening ceremony.

Lillian **Fulata** Shawa-Siyuni expressed her appreciation AGA-Africa whom she termed the National Prosecution Authoritu Zambia's forever partners, for once again coming through. She added, "In addition to punishment for crimes, confiscation of illicit gains and depriving criminals of their enjoyment and use, has proved to be one of the most effective ways of eliminating criminal activity the world over."

Markus Green affirmed that asset recovery is an extremely important component of a well-functioning working, criminal justice system.
