Based in the United States, the Attorney General Alliance (AGA) began as a bipartisan group comprising chief legal officers of 15 western states and three Pacific territories with the primary function of providing a forum for legal officers to cultivate knowledge, co-operate on issues of legal concerns and coordinate actions which improve the quality of legal services available to different institutions. Over the last 20 years the Attorney General Alliance has expanded beyond its original regional designation to count all US states as participants.



About the AGA-Africa Programme

Established in 2016, the Attorney General Alliance-Africa (AGA-Africa) is a programme operated under the auspices of the Attorney General Alliance (AGA) – a non-partisan, not-for-profit organization – based in the US. The AGA-Africa Programme collaborates with African Ministries of Justice, the Judiciary, Attorneys General, Solicitors General, Public Prosecution Offices and Law Enforcement Agencies to share knowledge and experience in the fight against cross-border crime.

AGA-Africa delivers programmes to build institutional and human capacity to support the rule of law through workshops, conferences and seminars to promote awareness and the effective detection, investigation and prosecution of transnational crimes. The programme is currently in 10 African countries: Ghana, Kenya, Malawi, Nigeria, Rwanda, Senegal, Seychelles, South Africa, Uganda and Zambia.

The Programme seeks to establish and foster robust relationships with justice and law enforcement agencies and other state and non-state actors in Africa to support the rule of law in combating transnational criminal activity such as Human Trafficking, Money Laundering, Cybercrime, Counterfeit Drugs, Wildlife Trafficking, Gender-based Violence, and other cross-border crimes.

3rd Annual AGA-Africa Conference

In June 2022, we held our 3rd Annual Conference themed 'Exploring New Frontiers for Cybersecurity and Africa's Digital Future' in collaboration with Microsoft in Accra, Ghana. We had the opportunity to showcase the Programme's crucial work in Africa with a focus on effective strategies to combat transnational criminal activity. We are grateful to

The Commonwealth Secretariat

We were delighted to strengthen partnership with Commonwealth Secretariat in 2022. In collaboration with the AGA-Africa Programme, the Commonwealth Secretariat organised the Regional Conference on Addressing Cybercrime in sub-Saharan Africa held on 17th-20th January, 2022 in Accra, Ghana. The AGA-Africa Programme also participated in the Commonwealth African Cyber Fellows Conference on 5th-6th July, 2022, Nairobi, Kenya. We are grateful to Dr. Tawanda Hondora, Head of the Rule of Law Division at the Commonwealth Secretariat for his steadfast support.

Election Dispute Resolution

In response to stakeholders' requests. the AGA-Africa Programme organised a series of Election Dispute Resolution training sessions for the Kenyan Judiciary, in collaboration with the Kenya Judiciary Academy and the Judiciary Commission on Elections. The training sessions were aimed at building the capacity of judges, magistrates and judicial staff who would be involved in the adjudication of elections and related matters. We proudly watched the Supreme Court Judges under the leadership of Hon. Lady Justice Martha Koome. Chief Justice and President of the Supreme Court of Kenya, put their training into immediate use as they adjudicated over the 3rd Presidential Election Petition under the Constitution of Kenya 2010.

This series of training sessions and workshops were replicated in Nigeria with the training of over **250** law enforcement officers and **80** judges on the role of law enforcement and the judiciary in maintaining the integrity of the

electoral process ahead of Nigeria's 2023 General Elections.

Sports

In our effort to engage and collaborate with like-minded organisations, the AGA-Africa Programme joined the Basketball League Africa (BAL) and the National Basketball Association (NBA) as an Associate Partner. We commend the leadership of Amadou Gallo Fall, President of the Basketball Africa League for their good work.

Advocacy Meetings

In 2022, in a bid to expand our reach and exposure and to solidify our relationships on the Continent, the Programme held advocacy meetings in Ghana, Sierra Leone, Tanzania and Zambia.

Development Partners

Book Donation

We were gratified by the generosity of Books For Africa (BFA) and the Thomson Reuters Foundation. who in collaboration with the AGA-Africa Programme, donated a full reference law library worth over forty thousand dollars (US\$40,000). The books are targeted at equipping the judiciary with the necessary knowledge and skills needed in the criminal justice sector. The Judicial Service of Ghana was first to receive these books on 5th December, 2022 at a handing over ceremony attended by the Chief Justice of Ghana, His Lordship Justice Kwasi Anin Yeboah. We are pleased to announce that the consignment of books destined for Kenya and Nigeria have arrived in the respective countries, pending official handing over scheduled for early 2023.

New Partnerships

To expand our reach and forge new relationships, the AGA-Africa Programme is actively seeking to establish new partnerships even as we strengthen the existing ones in our efforts to fight transnational crime. To this end, the Programme signed an MoU with Microsoft on 19th January, 2022 in Accra, Ghana; Sports for Education and Economic Development (SEED) Project on 4th March, 2022 in Dakar, Senegal; the Drug Enforcement Commission (DEC) of Zambia on 16th March, 2022, the Anti-Corruption Commission of Zambia on 17th May, 2022, the Anti-Corruption Bureau of Malawi on 20th September, 2022, the Malawi Police Service on 24th October, 2022 and the Judiciary of Zambia on 1st December, 2022.

Overview



The following Report is a chronicle of the activities that have taken place in 2022. The Report details the Programme's **Highlights**, recaps our **Core Mandate Areas**, the activities that we did in relation to those areas, and the events that took place in our 10 member countries.

2022 Highlights

Regional Conference on Addressing Cybercrime in sub-Saharan Africa in collaboration with the Commonwealth Secretariat

The AGA-Africa Programme participated in the Regional Conference on Addressing Cybercrime held on 17th -20th

January, 2022, Accra. The Programme hosted a workshop to enhance the understanding and skills of judicial officials and practitioners specifically in modern investigative techniques, practical approaches, the evolving legal skills necessary to combat cybercrime, the efficient use of prosecution resources, and the proper use of administration of justice.

At the opening event, Head of Rule of Law, Commonwealth Secretariat, **Dr. Tawanda Hondora** observed that countries in Africa lack adequate laws, policies and institutions to address cybercrime effectively. "There is need to raise awareness on the scale, nature, impact and solutions to the growing problem of

cybercrime in sub-Saharan Africa," he said.

In his remarks, His Lordship Kwasi Anin Yeboah, Chief Justice of the Republic of Ghana submitted that due to the borderless nature of the advances in technology and widespread use of the internet, there are great challenges as well as opportunities for all. He added: "There is therefore the imminent need for greater international cooperation and collaboration to promote stability in cyberspace while tackling crime in this realm."

Markus Green, Board Member, AGA-Africa Programme made an impassioned appeal: "Help us stay ahead of the criminals. This

is because just as the criminals are organised, the justice system must also be organised and all stakeholders must work together to fight organised crime."

Regional Director of Microsoft Corporation in charge of Emerging Markets and Engineering, Mark Ihimoyan, expressed optimism about the collaboration with the AGA-Africa Programme. "The partnership with AGA-Africa will enhance the exchange of information, strategies and training to prevent, regulate, investigate and prosecute cybercrime in Africa."

► AGA-Africa Partners with National Basketball Association (NBA), Basketball Africa League (BAL), SEED Academy among others



The Worldwide Appeal and Power of Sports -Tears, Jeers, and Cheers by Otubea Asare

American football, basketball, track and field, and Formula 1 racing are popular sports with legions of global fans, making sports a lucrative multibillion dollar industry that has grown from \$349.50 billion in 2021 to \$501.43 billion in 2022, with a projected growth of \$707.84 billion for 2026. As such, as a multi-billion dollar industry, sport has the power to promote upward mobility through scholarships, scholastic exchanges, and sports programs in colleges, universities or sports academies, such as the AGA-Africa affiliated SEED Academy in Senegal.

Through sports, students fulfil their professional sports aspirations and are catapulted to economic security, particularly in countries where there is a shut-out from other lucrative professions due to discrimination, lack of educational opportunities, and funding. These opportunities are, however, limited when it comes to women, who continue to face gender pay disparity, calling for enhanced marketing, higher investments, and ownership by women to help improve this state of affairs.



Within the African Continent, athletes such as Eliud Kipchoge, Kylian Mbappe, Yunus Musah, Bryan Habana, and Catherine Ndereba continue to dominate the world's sporting stage, where they join the likes of Bill Russell, Michael Jordan, Kobe Bryant, LeBron James, and Usain Bolt, whose influence extends beyond sports. Such influence is important as it can be used to spread important political messages as seen by the U.S. diplomatic protest of the Beijing 2022 Winter Olympics; and the taking of a knee at sports games. It can further be used to raise awareness on issues that are particularly prominent within the sporting industry such as instances of domestic abuse; sexual and gender based violence; and trafficking. Idolised professional athletes thus have a platform few others possess, and with it comes tremendous responsibility.

In recognition of the issues of domestic abuse; sexual and gender based violence; and trafficking that are commonplace within the sporting industry, the Attorney General Alliance - Africa Programme partnered with the Basketball Africa League to raise awareness on these issues, as well as, equip stakeholders with the tools needed to tackle these crimes. Moreover, through this partnership, the AGA - Africa has been able to inspire, empower, and elevate youth across the continent and empower players to become strong allies to local women. The work with the Basketball Africa League is in addition to the numerous training and workshops that the AGA-Africa Programme carries out to equip criminal justice actors and relevant stakeholders, in the 10 African countries that it has partners in, with the knowledge and skills needed to tackle these crimes.

Anti-Human Trafficking

An increasing number of countries in Africa – and indeed the world over – can be classified either as source, transit, or destination countries for victims of human trafficking. Human trafficking falls into several categories, including forced labour, sexual exploitation, and organ trafficking. It is generally acknowledged that in many cases, it is increasingly difficult to identify, investigate and prosecute human trafficking cases.

The AGA-Africa Programme's training workshops and seminars on human trafficking are focused on how one should identify, investigate, and prosecute human traffickers as well as best practices in the protection and rehabilitation of actual or potential victims of human trafficking.

In 2022, the Programme organised the following activities with respect to its anti-human trafficking efforts:

The report also references CGTN's findings that more than 90% of African businesses are operating without the necessary cyber security


protocols in place as it lists online scams, digital extortion, business email compromise, ransomware and botnets as the top 5 cyber threats in Africa.

The AGA-Africa Programme works with stakeholders engaged in tackling cybercrime to build and strengthen internal capacity. The Programme strives to promote awareness on the dangers of cybercrime in addition to facilitating workshops focused on the investigation and prosecution of cybercrime.
